CALL TO ORDER:

The Chairman called the regular meeting to order. Mr. Nicely gave the invocation and the audience remained standing for the Pledge of Allegiance.

MINUTES:

Hearing no corrections or deletions, the Chairman declared the following minutes approved as submitted: (1) a regular meeting held on June 5, 2018; and (2) an adjourned meeting held on June 12, 2018.

PUBLIC COMMENT (5 MINUTE TIME LIMIT):

No one spoke at this time.

MS. SUSAN HAMMOND, VDOT RESIDENT ENGINEER - VIRGINIA DEPARTMENT OF TRANSPORTATION UPDATE:

Ms. Susan Hammond, VDOT Resident Engineer, gave a report on the following VDOT activities:

<u>Maintenance</u>

- Completed spring mowing.
- Cut brush and weeds at intersections for sight distance.
- Completed emergency slope repair on Route 604.
- Repaired shoulders County-wide.
- Skin patching County-wide.

Construction

- Exit 21 project nearing completion. Major ticket items are complete. Working on punch list items now. Signal timings will continue to be evaluated as the truck stop and school opens.
- Route 638 Natural Well bridge demolition scheduled for next week.

Mr. Nicely asked if VDOT takes care of Ridgeway Street and if the Smart Scale application by Clifton Forge will take the road into consideration. Ms. Hammond replied that they do not take care of Ridgeway Street and that the Smart Scale application is more for pedestrian facilities.

Mr. Garten thanked Ms. Hammond as the slate that has collected at the bottom of the Rt. 220 high wall has been cleaned off and looks good.

APPROVE RESOLUTION OF SUPPORT FOR THE TOWN OF CLIFTON FORGE'S VDOT SMART SCALE APPLICATION:

WHEREAS, the Commonwealth of Virginia now prioritizes transportation projects for funding based on the cost effectiveness of those projects to meet performance goals, as established by the Smart Scale program; and

WHEREAS, Clifton Forge Town Council plans to submit an application for an allocation of funds for a project under the Smart Scale prioritization program; and

WHEREAS, it is identified in the VTRANS 2025 Needs Assessment as part of the Urban Development Area; and

WHEREAS, the County understands this project to include the provision of a bike lane, sidewalks, and crosswalks on Ridgeway Street/U.S. 60 from Dabney S. Lancaster Community College (DSLCC) to Roxbury Street; and

WHEREAS, the Town of Clifton Forge has already begun the design process for this project and is committed to delivery; and

NOW, THEREFORE, BE IT RESOLVED that the Alleghany County Board of Supervisors hereby supports the application to be submitted by the Town of Clifton Forge for the improvements described to compete for State and Federal funding under the Smart Scale Program.

APPROVE AWARD OF OUTFITTER CONCESSIONAIRE CONTRACT TO JAMES RIVER BASIN CANOE LIVERY, LTD:

Mr. Williams reviewed a memo from him to the Board which is included in the agenda packet. The memo is as follows:

Requests for Proposals for the Outfitter Concessionaire were received prior to 2:00 p.m. on April 23, 2018. One proposal that meets all of the qualifications put forth in the RFP was received. The Concessionaire will provide equipment rentals, shuttle service, organized trips, etc. along the Jackson River Scenic Trail and Jackson River as well as other outdoor locations. The business will be located in the facility being constructed at Intervale between the Jackson River Scenic Trail and the Jackson River.

The Concessionaire contract will initially be for five years with options for renewal. The Concessionaire will be responsible to pay Alleghany County 6% of their gross revenue the first year, 7% the next year, and 8% each year after. They will also be responsible for all taxes, the building utilities, and custodial care of the facility.

It is staff's recommendation that the Board award the Concessionaire contract to James River Basin Canoe Livery, Ltd., of 653 Lowe Street, Buchanan, Virginia 24066 and authorize Mr. Lanford to sign all associated contract documents. James River Basin Canoe Livery is more familiarly known as Twin River Outfitters and plan to do business locally as Alleghany Outdoors.

Mr. Williams added that the percentage for payment of gross revenue was phased in at their request due to the potential of losing funds the first couple of years until they are established. He commented that their financial data shows that once established they would be paying the County over \$13,000/year. He mentioned that they are also required to pay 3% of gross revenue to the Forest Service for use of their access points.

Mr. Garten stated that some contracts have a 1 ½% cost of living increase. He commented that this is a five year contract that caps out at 8%. He asked if the percentage can be renegotiated at renewal. Mr. Williams replied that it can. He mentioned that he looked at what other localities charge and the Roanoke County Explore Park concessionaire pays 10%; however, with our cap at 8% plus the 3% they would have to pay the Forest Service they total 11%.

Mr. Garten asked about the maintenance in regards to grass, snow removal, road upkeep, etc. Mr. Williams replied that the County would still cut the grass and snow removal would not be needed in the off season. He commented that this is a public access point and it would be hard to say from where damage occurred on the road.

Mr. Bennett stated that the outfitter would only be using the facility for a portion of the year and organizations/individuals would be able to use the meeting room area. Mr. Williams added that a fee for rental has not been set at this time, but the County currently charges \$45.00 to rent the Sharon Senior Center.

Ms. Vannorsdall asked how long the outfitter would operate during the year. Mr. Williams replied from April through October depending upon the weather.

Mr. Nicely asked if there would just be canoe rentals. Mr. Williams replied there would be bike rentals too.

Mr. Nicely stated that the Homestead uses the trail and they charge patrons \$50/day, but do not want to speak with the County or address the issue while they are reaping the benefits. He commented that if the County extends the trail into Bath County then they will capitalize more.

Mr. Williams stated that having an outfitter will be more economical and could pull business from the Homestead back to the County.

Mr. Shull asked if the County has met with Bath County representatives. Mr. Williams replied that they met with the Bath County Administrator and Planner. He commented that they support the trail and see the benefit of having another main trailhead. He mentioned that the Bath County Board of Supervisors approved a resolution of support for the trail to help with funding applications, have committed \$5,000, have offered to police the trail in Bath County, and potentially assist with utility costs. He stated the Homestead has a new Executive Director that has offered no communication or financial support.

Mr. Lanford commented that the minimum operation year for the outfitter is April 1st through October 31st. He stated that Mr. Williams has reached out to Bath County which is supportive, but the Homestead has been non-responsive. He mentioned that the County will continue to reach out to them.

Mr. Griffith suggested that the Homestead get a business license to use the trail.

Mr. Bennett stated that the outfitter would just be leasing the building and the public would still have access to the rest of the property (ramp, etc.). Mr. Williams replied that this is correct.

There was some discussion regarding the Forest Service fee of 3% being nation-wide and is only charged to outfitters and not the public.

On motion of Mr. Garten, seconded by Ms. Vannorsdall, that the following resolution be adopted:

APPROVE THE SUBMITTAL OF GRANT APPLICATIONS FOR PHASE 5 OF THE JACKSON RIVER SCENIC TRAIL TO THE APPALACHIAN REGIONAL COMMISSION AND THE DEPARTMENT OF CONSERVATION AND RECREATION:

Mr. Williams reviewed a memo from him to the Board which is included in the agenda packet. The memo is as follows:

The last time we discussed Phase 5 of the Jackson River Scenic Trail project the Board requested that staff try to engage Bath County and the Omni Homestead on their willingness to support the project. The Omni Homestead has been non-responsive in our efforts to make contact. A meeting was held with staff from Bath County. They were very supportive of the possibility of the completion of Phase 5. The Bath County Board of Supervisors adopted a resolution of support and committed \$5,000 to the project in an effort to help our work in securing grant funding. Bath County staff also said they would provide a law enforcement presence on Phase 5 once complete and entertained the idea of being responsible for utility costs at the future trailhead facilities. At a previous meeting the Board approved for an application to be submitted to the VDOT revenue sharing program for Phase 5. Our last conversations with VDOT regarding the application was that it scored well and has a good chance of being funded. The Commonwealth Transportation Board should make official announcements sometime in July.

In our effort to provide the required 50% match to the revenue sharing grant we may receive, staff would like to apply for two more grants. This request is being brought to you now because one of the grants is time sensitive.

I am requesting the Board of Supervisors adopt a resolution of support for the submittal of a grant application to the Appalachian Regional Commission's (ARC) grant program in the amount of \$500,000 for Phase 5 of the Jackson River Scenic Trail project. The grant is a 50/50 reimbursable grant.

I am also requesting the Board adopt a resolution of support for the submittal of a grant application to the Virginia Department of Conservation and Recreation's (DCR) Recreation Trails Program in an amount up to \$200,000 for Phase 5 of the Jackson River Scenic Trail project. The grant is a 80/20 reimbursable grant. The opportunity for this grant was recently announced and is due in July.

The grants will be used to match the revenue sharing grant if received, as well as each grant matching the other. Other funding sources will be sought to cover any outstanding match and remaining costs. Phase 5 is the final phase of the Jackson River Scenic Trail project. It consists of an additional 1.6 miles, as well as a 1.33 acre trailhead along Cole's Mountain Road with associated amenities.

Mr. Williams added that he received notification from the County's engineer that VDOT has approved the \$954,000 VDOT funding, but the County has not received official notification from VDOT.

Mr. Nicely stated that he has a problem with Phase 5 benefitting the Homestead as they have given no support. He commented that the County does all the work and then they will not speak with Mr. Williams.

Mr. Williams stated that it would be nice to have them on Board as it will be a big benefit to Bath County and the Homestead with the possibility of another outfitter on that end.

Mr. Griffith commented that the Homestead should have to get a business license.

Mr. Williams mentioned that the County could do a fee for businesses to drop-off, but the problem would be how to police it. He commented that he will look into this further.

Mr. Lanford stated that the County will continue to reach out to the Homestead and look into fee options.

On motion of Mr. Garten, seconded by Mr. Shull, that the following resolution be adopted:
