CALL TO ORDER:

The Chairman called the regular meeting to order. Mr. Nicely gave the invocation and the audience remained standing for the Pledge of Allegiance.

Hearing no corrections or deletions, the Chairman declared the following minutes approved as submitted: (1) a regular meeting held on June 4, 2019; and (2) an adjourned meeting held on June 11, 2019.

PUBLIC COMMENT (5 MINUTE TIME LIMIT):

Mr. John Moser, 706 Church Street, spoke regarding the following items: (1) the County should pro-rate taxes; (2) the Radar bus not being designed for regular people but for the handicapped; and (3) he would like Clifton Forge absorbed into the County (water/sewer costs, double services, etc.).

MS. SUSAN HAMMOND, VDOT RESIDENT ENGINEER - VIRGINIA DEPARTMENT OF TRANSPORTATION UPDATE:

Ms. Susan Hammond, VDOT Resident Engineer, gave an update on the following VDOT activities:

<u>Maintenance</u>

- Plant mix and slurry completed on Wesgate hill.
- First round of mowing is complete on primary and secondary routes. Interstate should be completed soon.
- Walls, medians, and curbing are being swept.
- Rt. 696 bridge approach near Selma Fire Department has been patched along with the box culvert near the entrance to the Extruder Plant.
- Patching underway on secondary routes.
- Rt. 220 north of Covington City Limits will be patched in the next two weeks.
- Sinkhole on Rt. 616 Rich Patch will be repaired this month.

Construction

Rt. 638 bridge replacement construction officially accepted.

Mr. Garten commented regarding the issues on the highwall on Rt. 220 near Honda Nissan. He stated that on Rt. 220 North approximately a mile from the Falls it looks like the northbound lane is falling off. He asked if Smokey Bear Lane will be patched and if so to let him know so he can let the carriers know. Ms. Hammond replied that Smokey Bear Lane will be patched and then paved and she will let him know.

Mr. Bennett asked if the repair to the culvert on Rt. 616 would occur overnight and if so could Boiling Spring fire and rescue be notified. Ms. Hammond replied that information will be out at least a week in advance of the closure and she will let Mr. Muterspaugh know.

APPROVE RESOLUTION OF SUPPORT FOR INCREASED FUNDING FOR THE NATIONAL PARK SYSTEM:

Mr. Lanford stated that there is information from the Roanoke Valley-Alleghany Regional Commission in the agenda packet with a resolution of support for increased funding for the National Park system. He commented that there is not a national park in the Alleghany Highlands; however, there are two (Blue Ridge Parkway and Booker T. Washington National Monument) in the RV-ARC region. He mentioned that it would benefit our area to show support as there are initiatives in our area (i.e. Longdale Recreation area, Gathright, etc.) that a dialogue will be started on and we will ask for support from the region.

On motion of Ms. Vannorsdall, seconded by Mr. Shull, that the following resolution be adopted:

RESOLUTION OF SUPPORT FOR INCREASED FUNDING FOR THE NATIONAL PARK SYSTEM

WHEREAS, America's National Park System is a living testament to our citizens' valor, our nation's hardships, our victories, and our traditions as Americans, and has been called "America's Best Idea"; and

WHEREAS, the National Park System preserves the diversity, culture, and heritage of all Americans, and serves as

WHEREAS, the National Park Service currently manages more than 400 nationally significant sites and an invaluable collection of more than 75,000 natural and cultural assets that span 84 million acres across all 50 states, the District of Columbia, and several U.S. territories and insular areas, including 22 park units in the Commonwealth of Virginia which contribute an estimated \$1.4 billion and over 15,000 jobs to the Commonwealth's economy; and

WHEREAS, the National Park Service's mission is to "to conserve the scenery, the natural and historic assets, and the wildlife therein, and to provide for the enjoyment of the same in such manner and by such means as will leave them unimpaired for the enjoyment of future generations"; and

WHEREAS, the National Park Service has the obligation to preserve our nation's history; promote access to national parks for all citizens; stimulate revenue to sustain itself and nearby communities; educate the public about America's natural, cultural and historical resources; and provide safe facilities and environments to enjoy these resources; and

WHEREAS, the National Park Service estimates a deferred maintenance backlog of \$11.9 billion, including over \$1 billion in Virginia alone, and includes repairs to aging historical structures, trails, sewers, drainage, thousands of miles of roads, bridges, tunnels, and other vital infrastructure; and

WHEREAS, the Blue Ridge Parkway and Booker T. Washington National Monument are both located within the Roanoke Valley–Alleghany region and face maintenance needs related to roads, stream erosion, trail maintenance, structural repairs to buildings and countless other needs related to preventative maintenance to ensure that visitors will continue to come to these important National Parks; and

WHEREAS, in 2018, 22.7 thousand park visitors spent an estimated \$1.3 million in the region while visiting Booker T Washington National Monument. These expenditures supported a total of 19 jobs, \$567 thousand in labor income, \$969 thousand in value added, and \$1.7 million in economic output in communities around Booker T Washington National Monument; and

WHEREAS, in 2018, 14.7 million park visitors spent an estimated \$1.1 billion in communities while visiting Blue Ridge Parkway. These expenditures supported a total of 15.9 thousand jobs, \$430 million in labor income, \$734 million in value added, and \$1.3 billion in economic output in communities surrounding Blue Ridge Parkway; and

WHEREAS, it is the responsibility of Congress to maintain America's national parks to ensure our natural places and our history are preserved and documented for future generations, and for the adjacent communities that rely on the direct and indirect economic benefits generated by visits to national park sites; and

WHEREAS, the U.S. Senate and House of Representatives has legislation under consideration (S. 500 and H.R. 1225 – known as the *Restore our Parks and Public Lands Act*), which will establish, fund, and provide for the use of amounts in a National Park Service and Public Lands Legacy Restoration Fund to address the maintenance backlog of the National Park Service, and for other purposes;

NOW, THEREFORE BE IT RESOLVED that the Alleghany County Board of Supervisors strongly encourages members of the Senate and the House of Representatives to support S. 500 and H.R. 1225, which will help to create a reliable, predictable stream of resources to address deferred maintenance needs in America's National Park System.

APPROVE SUBMITTAL OF A GRANT APPLICATION FOR PHASE 5 OF THE JACKSON RIVER SCENIC TRAIL TO THE DEPARTMENT OF CONSERVATION AND RECREATION:

Mr. Williams stated that the Board passed a resolution last year for funding, but it was not funded and he would like to apply again this year. He reviewed a memo from him to the Board which is included in the agenda packet. The memo is as follows:

I am requesting the Board of Supervisors adopt a resolution of support for the submittal of a grant application to the Virginia Department of Conservation and Recreation's Recreation Trails Program in an amount up to \$400,000 for phase 5 of the Jackson River Scenic Trail project. The VDOT revenue sharing grant the County was previously awarded will be used as the match. Phase 5 is the final phase of the Jackson River Scenic Trail project. It consists of an additional 1.6 miles as well as a 1.33 acre trailhead along Cole's Mountain Road with associated amenities.

Ms. Vannorsdall asked if there was any feedback from DCR as to why the project was not funded last year. Mr. Williams replied that DCR has limited funds available and are very competitive. He commented that they made minor suggestions for the application that are being incorporated into this one.

Mr. Nicely asked about the matching funds. Mr. Williams replied that the VDOT revenue sharing grant that has been awarded will be the match.

On motion of Ms. Vannorsdall, seconded by Mr. Shull, that the following resolution be adopted:

WHEREAS, in accordance with Department of Conservation and Recreation's Virginia Recreational Trails Program procedures, it is necessary that a formal resolution from the governing body be received authorizing the submittal of an application for funding;
