Public Hearing to consider amendments to Chapter 62-Water, Sewer and Sewage Disposal of "The Code of the County of Alleghany, Virginia" in Section 62-71 - Rates to increase water and sewer rates effective July 1, 2017. The water rate, sewer rate, and sewer only rate would each increase \$1.00. The overage rate would increase by \$0.50 per 1,000 gallons. The deposit amounts would also increase for owners and tenants in Sec. 62-140.
